Mayor opens Men's Shed

Mayor of Dorchester Robin Potter helped launch a community workshop project when he cut a ribbon to officially open the Dorchester Men's Shed.

The not-for-profit facility forms part of a new movement that began in Australia to offer space to work on projects involving wood and meet other people.

Graeme Trinder, founder and secretary of the Dorchester Men's Shed, started exploring the idea last November after discovering the nearest ones were in Poole and Wincanton.

The facility gives men - and women - the opportunity to share skills and to socialise as well as complete a range of projects large and small.

The official opening of the facility at Whitfield in Bradford Peverell included the presentation of a cheque from Rosemary Robinson of Magna Housing Association - one of the sponsors and supporters of the shed.
